1. I acknowledge and agree that the payment for the renewal is due on the same day when the current term expires. For instance, if my current term expires on March 13, I should pay for the renewal before the due or on the same day.
2. I understand and agree that if I need to change any information regarding the shipping address or the product, I must submit the updated information at least one month before the renewal due date.
3. To receive UKON commission from downline(s) sales, the applicant must be enrolled in the UKON program, and UKON account must be active (renewal/repeat purchase).
4. It is advisable for the applicant to purchase an E8PA membership to receive the E8PA Cardholder price and other associated member benefits.
5. UKON DD program allows the distributor to maintain their SP status for 120 days without making machine direct sales. UKON Sigma program for 365 days.
6. A new UKON ID number will be issued for the first purchase. If UKON DD is renewed three times, including the first purchase, it will become a permanent account.
7. If UKON DD is not renewed more than twice, it will be terminated. A Permanent account will not be terminated. UKON Sigma New can be purchased as a renewal under it.
8. UKON renewal is unable to apply Enroller Program.
9. Once terminated, the distributors will not be eligible to receive any commission from any UKON sales.
10. While the applicants can receive email reminders when their subscription is due to renew, it is the distributor's responsibility to renew on time.
11. If the applicant does not renew their UKON DD account and has not made a direct sale within the last 3 months, their Special Point status will be cancelled.
12. Applicants who enroll as UKON DD Users are not eligible to receive any commissions and cannot renew the account. Three (3) UKON DD sales will count as one machine sale for the 6A title incentive bonus.
13. If there is a delivery failure due to incorrect or incomplete shipping details, the Applicant is responsible for paying any additional shipping fees.
14. The recipient of an international shipment may be subject to import fees, GST, or VAT that are levied once the shipment reaches their country. Additional charges for customs clearance must be paid by the recipient. Customs policies vary widely from country to country, so it is recommended to contact the local customs office for more information. When customs clearance procedures are required, it can cause delays beyond the original delivery estimate.
15. Return Policy – Enagic Singapore Pte Ltd accepts returns of all unopened items within 60 days of receipt for a full refund, excluding shipping fees. ## Ukon™ DD and Ukon™ Σ3DD Q & A

### 1. Definition of Identities

New Customer – Not registered Distributor or User of Enagic when the Initial purchase is Ukon™. Kangen Water Distributor – Registered as Enagic Distributor with machine purchase.

### 2. How much does 1 set of Ukon™ DD and Ukon™ Σ3DD cost?

Standard price Ukon™ DD SGD 935 and Ukon™ Σ3DD SGD 2,430. (Price excluded delivery cost/import tariff/tax)

### 3. How much are an Ukon™ DD and Ukon™ Σ3DD commission points?

Each Ukon™ point is THB 1,300-1500 and Ukon™ Σ3DD is THB 3,200-3300 (depend on Exchange rate, but you must possess an active Ukon™ DD ID to receive Ukon™ DD commission).

### 4. How much will I earn when I sell Ukon™ DD?

Ukon™ DD program contains 8 points; commission will be according to your register Level of Rank. It depends on the type of your customers which could be New Customer / Kangen Water Distributor.

#### - New Customer

Selling Ukon™ DD to New Customer will benefit you to earn commission as your Kangen Water machine registered rank. For example, you are 6A, sponsor a New Customer to buy Ukon™ DD, you will earn THB 9,000 (THB 1,500 x 6 Ukon™ DD point).

#### - Kangen Water

Distributor If your downline partner or downline team member buys Ukon™ under herself/himself, you will be paid according to the level of leg that such downline customer is in. For example, a Ukon™ DD sell to your downline customer in your 3A leg will offer you a maximum of THB 4,500 (THB 1,500 x3 Ukon™ DD points), even if you are currently in 6A. This applies to your own purchase. As a Kangen Water Distributor, when you purchase Ukon™ DD, you will receive the same amount of points as your Kangen Water rank. So, if you are in 3A, you will be paid THB 4,500 (THB 1,500 x 3 points) for your own Ukon™ DD purchase!

### 5. Is there any limitation for Ukon™ DD and Ukon™ Σ3DD ID renewal?

Yes. Ukon™ DD and Ukon™ Σ3DD ID renewal application could be registered as 1A rank and will receive 1 Ukon™ point only. The rest of points will be passed up.

### 6. Can I sell Ukon™ and Kangen Water machine to a customer?

No. A customer should purchase a machine for Initial registration, Ukon™ DD can be bought and sponsor by such Kangen Water Distributor ID (or vice versa).

### 7. Do I need to submit application form when apply for the renewal of my Ukon™ ID?

Yes, please also fill in Repeat (e.g., 1 or 2 or ....) Time on the form.

### 8. Does Ukon™ sales count the same as Kangen Water machine sales?

Counting group sales for Level of Rank, the ratio of having Ukon™ DD, Ukon™ Σ3DD and Kangen Water machine is 1:1. In other words, selling Ukon™ DD count as 1 unit of group sales. However, when it comes to New Title Incentives/Bonus, the ratio is 3:1.

### 9. How to count the Due Date & apply my Ukon™ DD or Ukon™ Σ3DD ID Renewal?

Due Date will be based on the date of your First Ukon™ purchase & registration. Please submit Renewal application Ukon™ DD every 4 months and Ukon™ Σ3DD every 1 year. e.g., First Ukon™ DD purchase & registration on 15th Jan., then the Due Date for the 1st Repeat will be by 15th May. Due Date for the 2nd Repeat will be by 15th Sept., etc. e.g., First Ukon™ Σ3DD purchase & registration on 15th Jan., then the Due Date for the 1st Repeat will be by 15th Jan next year

For your renewal order, please apply a week ahead the Due Date. Once your renewal reaches its Due Date, termination will be processed the next day.



#### 10. Can I recruit from another Kangen Water line?

No, you are not permitted to recruit out of line. All Kangen Water Distributors keep the current customers and structure.

#### 11. How does SP work with Ukon™ DD and Ukon™ Σ3DD?

Ukon™ program allow Distributors maintain their SP status for 4 months of Ukon™ DD and 1 year of Ukon™ Σ3DD without making machine direct sales.

#### 12. What will happen if I miss my Renewal?

Distributors take responsibility to submit their renewal application on time. If your Ukon™ DD ID does not apply Renewal twice continuously by Due Date, it will be terminated without any prior notice. Renewal your Ukon™ DD ID two times will trigger it becoming permanent and not to be terminated. Ukon™ Σ3DD is permanent ID. Permanent & Non-Permanent Ukon™ DD and Ukon™ Σ3DD ID are not entitled to receive Ukon™ DD commission once you miss the Renewal.

#### 13. Can I buy Ukon™ DD as many as I want?

You are allowed to purchase 1 set in a single period only. The more you purchase does not mean the SP can last for longer period. Can have only one Ukon account under machine account.

#### 14. Can I use Ukon™ DD to step up 6A?

No. Ukon™ DD can only be accepted to register to step up 2A-5A. For Ukon™ Σ3DD is permanent account, can be accepted to register to step up 6A.

#### 15. What is UKON™ U.S. Version mean?

It is for Vegetarian. Please mark a 'tick' on the product column if U.S. Version is required.

#### 16. How do Ukon™ DD and Ukon™ Σ3DD IDs count for New Title Incentive/Bonus?

New Title Incentive/Bonus will be divided into 3 parts when Ukon™ DD is involved. When Distributors who entitle to obtain New Title Incentive/Bonus, first part (1/3) will be released. When Ukon™ DD IDs complete 1st Repeat orders, second part (2/3) will be released. When Ukon™ DD IDs complete 2nd Repeat orders and get permanent Ukon™ DD IDs, Final part (3/3) will be released. Ukon™ Σ3DD counts as 1 unit for New Title Incentive/Bonus.

#### 17. Can I use Ukon™ DD and Ukon™ Σ3DD to complete my Tokurei registration?

No. Tokurei registration must be completed with machine order.

#### 18. Existing Tokurei can sponsor Ukon™ DD and Ukon™ Σ3DD sales?

No.

#### 19. Can Ukon™ DD ID sponsor Tokurei registration?

Only Permanent Ukon™ DD and Ukon™ Σ3DD ID can sponsor Tokurei registration.

#### 20. Who qualify for E8PA member price purchase?

You are Kangen Water Distributor / Permanent Ukon™ DD and Ukon™ Σ3DD Distributor, with purchase of E8PA Card. When you are active E8PA Distributor, you are quality for E8PA member price purchase.

#### 21. What is the way to release Ukon™ DD and Ukon™ Σ3DD commission?

Ukon™ DD commissions are paid according to the commission payment cycle. Permanent & Non-Permanent Ukon™ DD ID are not entitled to receive Ukon commission once you miss the Renewal.

**\*Any irrational purchase that might attempt to go against our company policy will limit your commission.**
